Effective January 1, 2025, Wellpoint will provide outpatient behavioral health benefits to all NJ FamilyCare members. This change will combine physical and behavioral health services under a single plan so that all your healthcare needs can be addressed together. The following services for both adults and children will be managed and billed by Wellpoint starting January 1, 2025:

Mental health services

- Mental health therapy/counseling
- Mental health partial hospitalization
- Mental health partial care
- Mental health outpatient hospital or clinic services

<u>Substance use disorder (SUD) services</u>

- Substance use disorder therapy/counseling
- Substance use disorder intensive outpatient treatment
- Substance use disorder detoxification/ambulatory withdrawal management
- Substance use disorder partial care
